

Marcia Grand Centennial Sculpture Prize Competition Call for Proposals

Purpose:

Building on the excellence of its graduate programs, the Marcia Grand Centennial Sculpture Prize Competition is intended to provide MFA-seeking graduate students with up to \$10,000 to support the completion of work in the sculptural/3D arts. The work supported by this award can be presented on or off campus; possible projects include:

- Land-art
- Site-specific sculpture/installation
- "Traditional" sculptural work
- Performance-based work incorporating 3 dimensional components.

Media Stipulations:

While this award is open to students from all divisions the proposed project must incorporate 3-dimensional media. This could be any of the formats listed above. The following stipulations will be required for all funded projects:

- 1. Students are encouraged to use environmentally sustainable materials in the execution of their art.
- 2. A list shall be provided of any and all toxic ingredients used either in the creation of the piece or in the final work as displayed. This list shall be considered to be a part of the work, and will be displayed in any installation of the work.
- 3. A list will be provided of any human or animal parts used whenever the work is displayed.

Award Amount

Up to \$10,000

Due Date

Proposals are due by 5:00pm on Friday, April 20th.

Eligibility

This award is open to MFA students of all disciplines who will be in their second or third year in the 18/19 school year and who meet the following criteria:

- A record of exhibitions both on and off campus displaying a dedication to presenting the artist's work in a professional manner.
- An outstanding record of academic achievement.
- A demonstrated commitment to the themes and media encompassed by this award.

Application Process

A completed application will consist of the following materials:

- 1. Application Cover Sheet
- 2. Project Narrative including:
 - a. A detailed description of your proposed piece or project.
 - b. A list of any possible toxic substances and/or human or animal parts to be used
 - c. A explanation of how the project fits into the larger conceptual trajectory of your work as an artist.
 - d. An accounting of how the project will benefit your professional goals as an artist
 - e. A list of past experiences that demonstrate your ability to execute the requirements of the project, both from a technical standpoint as well as with respect to the project's logistical requirements.
 - f. A description of where and when this work will be displayed.
 - g. Plans for obtaining approval for any public or site-specific installations.
- 3. Curriculum Vitae
- 4. Budget (include a justification requested items)
- 5. A portfolio of past work (10-15 images in a single pdf or ppt document)

Your application must be signed by your committee chair before being submitted by email to the School of Art graduate coordinator, Megan Bartel, mbartel@email.arizona.edu.

Note: Any student whose proposal is funded will be required to submit a one-page report outlining outcomes from the project within one year of the award.
